MEMBERSHIP AGREEMENT:

I commit to membership in the bk farmyards Egg CSA for the 2010 season. I will pick up my share every week 22 weeks, between 11am and 1pm from June 5th to October 30th. If I am unable to pick up my share I will have a friend or relative pick up my share for me, or forfeit my share that week.

I am a resident of Brooklyn. As a member I commit to supporting the Imani garden by attending at least one work day this season.

I understand that CSA involves sharing the rewards and risks with bk farmyards. I understand that my share may vary from week to week, and that is no guarantee of the exact amount of my share.

I agree not to hold bk farmyards or NYRP or anyone acting on its behalf, including any agents, officers, volunteers or employees, responsible for any damages resulting from injuries sustained while engaged in any event or activity, including but not limited to weekly distribution or volunteer days.

I hereby authorize bk farmyards to use, reproduce, and/or publish all written and/or visual materials, including photographs, that may pertain to me. I understand that this material may be used in various publications, public affairs releases, recruitment materials, or for other related endeavors.
